Influence on dyed goods

- Shade : Virtually no change
- Fastness properties : Virtually no influence
- Storage Stability : Stable for 6 months if stored in a cool & dry place.

Method of Application:

Mirasoft – N can be applied by both exhaust and padding method. The concentration would depend on type of fibre and the effect desired. It is applied as a self-finish or in combination with other finishing chemicals and optical brightening agents.

The concentrations to be used are:

Exhaust Method

Mirasoft – N → 2 – 3%

Padding Method

Mirasoft – N → 30 – 40 g/l (with 70 – 80% pick up)
